# How do we collect your data?

You directly provide us with most of the data we collect. We collect data and process data when you:

- Sign up online for our newsletter on MailChimp.
- Voluntarily complete a Google Form or voluntarily provide feedback in any other way e.g. email or via social media.
- Use or view our website via your browser's cookies.

## How will we use your data?

We collect your data so that we can:

- Email you with information about Development Matters 2020, and early years education and childcare.
- Update and improve the documents we share online.

We will not share your data with anyone else.

## How do we store your data?

We store your data on our secure Google Drive and on MailChimp.

## Marketing

We would like to send you information about our work to support the implementation of Development Matters 2020, and wider support for early education and childcare.

If you have agreed to receive emails, you may always opt out at a later date.

You have the right at any time to stop us from contacting you.

If you no longer wish to be contacted please click 'unsubscribe' in the footer of our newsletter.

### What are your data protection rights?

We would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** – You have the right to ask us for copies of your personal data. We may charge you a small fee for this service.

**The right to rectification** – You have the right to ask us to correct any information you believe is inaccurate. You also have the right to ask us to complete the information you believe is incomplete.

**The right to erasure** – You have the right to ask us to erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to ask us to restrict the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to our processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to ask us to transfer the data that we have collected to another organization, or directly to you, under certain conditions.
